SECTION 4: FIRST AID MEASURES

4.1. Description of first aid measures

<u>Inhalation:</u>	Move into fresh air and keep at rest. In case of persistent throat irritation or coughing: Seek medical attention and bring these instructions.
<u>Skin contact:</u>	Remove contaminated clothing. Wash skin thoroughly with soap and water. Get medical attention if any discomfort continues.
<u>Eye contact:</u>	Immediately flush with plenty of water for at least 15 minutes. Remove any contact lenses and open eyelids widely. If irritation persists: Seek medical attention and bring along these instructions.
<u>Ingestion:</u>	DO NOT induce vomiting. Get medical attention immediately. If vomiting occurs, keep head low so that stomach content doesn't get into the lungs. Aspiration hazard. Droplets of the product aspirated into the lungs through ingestion or vomiting may cause a serious chemical pneumonia. Rinse mouth with water. If unconscious: Loosen tight fitting clothes and place in recovery position.

SECTION 5: FIREFIGHTING MEASURES

5.1. Extinguishing media

Extinguishing media: Extinguish with foam, carbon dioxide, dry powder or water fog. Cool containers exposed to heat with water spray and remove container, if no risk is involved.

Do not use water jet as an extinguisher, as this will spread the fire.

7.1. Precautions for safe handling

Safe handling advice: Observe good chemical hygiene practices. Avoid inhalation of oil mist and contact with skin and eyes. Avoid prolonged and repeated contact with oil, particularly used oil. Wash hands before breaks and before smoking, eating or drinking.

Technical measures: Use work methods which minimise oil mist production. Do not smoke or use open fire or other sources of ignition.

Technical precautions: When working with heated oil, mechanical ventilation may be required.

Technical measures for safe storage: Store in tightly closed original container in a well-ventilated place. Containers, which are opened, must be carefully resealed and kept upright to prevent leakage. Ensure that the container is undamaged and has a proper label. Use appropriate containment to avoid environmental contamination.

8.2. Exposure controls

Engineering measures: Provide adequate ventilation. Observe Occupational Exposure Limits and minimize the risk of inhalation of vapours and oil mist.

Respiratory equipment: In case of inadequate ventilation use suitable respirator. Use respiratory equipment with gas filter, type A1. If the product is heated under manual handling, use suitable mask with filter A1P2 or A2P2.

Hand protection: Nitrile gloves are recommended. If signs of wear and tear are noticed then the gloves should be replaced. The most suitable glove must be chosen in collaboration with the gloves supplier, who can inform about the breakthrough time of the glove material.
